BIOGRAPHY

Over the past 30 years Kevin has developed an extensive scope of project experience in the field of:

- landscape architecture
- environmental planning
- park and waterfront planning
- urban design
- heritage landscape restoration
- sports field design
- transportation corridor restoration
- recreational trail design

His work is carried out within a well-developed system of public participation; a finely honed ability to interpret the physical and cultural landscape, and his highly creative design ability. These talents are augmented by strong graphic presentation and public facilitation skills.

Public Sector

Kevin has worked with all levels of government including federally with Parks Canada during the early planning process for Pacific Rim National Park in British Columbia. Provincially, Kevin has worked for the Ministry of Education at their Sir James Whitney campus in Belleville. He served as the Regional Landscape Architect for the Ontario Ministry of Transportation (MTO) during the twinning of Hwy 416 from Hwy 401 to Ottawa, and during the environmental planning stages for Hwy 417 from Ottawa to Annprior. Kevin also provided MTO with pertinent design standards and policies regarding the accommodation of bike lanes on Hwy 33 from Bath to Picton via the Glenora Ferry.

Municipal

Municipally, Kevin has worked for many towns and cities across eastern Ontario including Kingston, Belleville, Quinte West, Gananoque, Loyalist Township, Leeds and Thousand Islands, and Sydenham Township. This work ranged from master planning and feasibility studies for municipal multi-use trail systems, park master plans, waterfront regeneration plans, the environmental and recreational component of numerous secondary plans, as well as at the more detailed stage for individual parks, sports fields, boat launches, ferry docks and playgrounds and splash pads.

Over the past 5 years, the bulk of Kevin's municipal work has been centred around the delicate balance of designating and designing public open spaces and facilities within the political and physical landscape of many municipalities. Invariably, over dozens of successfully completed projects, the result has been a newly created recreational asset carried out within budget and on time. Examples include the historically sensitive renovation of City Park Playground in Kingston, which included a splash pad; work on the Quinte West Waterfront Regeneration Plan which resulted in over 7 years of progressive trail construction which is now part of the Ontario

Waterfront Trail through Trenton. Most recently, Kevin has assisted the City of Belleville with Boyd Park, a remnant of nature within a new residential subdivision.

Private Sector

Kevin has also been the lead designer on projects in the private sector, including the design of the primary waterfront open space at Riverpark Subdivision in Kingston and a recently completed study for the renaissance of the Town of Batawa and its adjacent riverfront.

Trails

- Planning, design of a heritage trail from Christ Church to the Mohawk Landing at Tyendinaga
- Planning and design of numerous section of Quinte West Waterfront trail (including boardwalks and boat launches and a marina
- a feasibility and management study for the Lower Trent Trail which connected Trenton to Glen Ross on the Trent River
- A Route Options Study for the City of Quinte West, which identified a way forward for the development of both a waterfront trail on the Bay and a riverfront connection in to the hinterland of Quinte West
- Environmental Planning and trail design for the Gananoque Trails Feasibility Study
- Design and negotiation for a connection along the Gananoque River below the Hwy 401 overpass to a provincial wildlife area north of the 401

Kevin's total project management style and his wide ranging knowledge of the design and construction process have been well received by a wide variety of clients during his 33 year career as a Landscape Architect.
